- Proven experience in conducting theatre workshops, rehearsals, and collaborative artistic processes

Applicants are encouraged to provide a comprehensive overview of their qualifications, including any relevant achievements or projects that showcase their ability to meet the specified requirements.

Evaluation of applications and award criteria

- First stage of the evaluation process will be technical check when the Evaluation Committee will go through all the applications to see if they are in compliance with the criteria stated in the technical information in the part "services required "of this document; as well as if the application contains all of the parts as stated in the section in the technical information in the part of this document. Only the applications satisfying all of the requirements will go the evaluation stage.
- The applications that passed the technical check will be accessed based on the following criteria:

Background to the assignment

The project "Dealing with the Past through Art, Education and Social Dialogue" has been designed in an authentic way, with the mission of achieving the objectives of the call under which it is being submitted.

The project addresses the lack of adequate dialogue on past conflicts, particularly those of the 1990s, which continue to have long-term consequences on social cohesion and mutual trust in post-conflict communities. In addition, there is a noticeable absence of thought-provoking events that encourage critical reflection. Many generations, especially young people, have not had the opportunity to learn about historical events, their causes, and their consequences, which creates barriers to mutual understanding and reconciliation. As a result, there is a deeply rooted lack of awareness about the importance of dealing with the past, the gender dimension of conflicts, and the impact of those events on contemporary social life, especially among generations born after 1990.

The project directly responds to the goals of the call related to promoting social cohesion, reconciliation, and strengthening mutual trust in society. By engaging diverse social groups, with a particular emphasis on young people, the project creates opportunities to confront past conflicts and establish a platform for constructive dialogue. This process is essential for overcoming deep divisions and disagreements rooted in the wars of the 1990s.

Grounded in artistic expression, education, and dialogue, the project contributes to social inclusion, education on important historical events, and the fostering of mutual understanding. In this way, it directly supports the objectives of the call related to strengthening social responsibility and building stable communities. The project provides tangible and lasting benefits to local communities, based on dialogue and education, while at the same time reducing potential sources of future conflict.

The overall aim of the project is to raise awareness about past conflicts, reconciliation processes, and the importance of dealing with the past through art, education, and social dialogue.

The project will focus on three key target groups: the general public, young people, and experts. The general public often lacks sufficient information about past conflicts and reconciliation processes, making it essential to raise awareness through various forms of art, dialogue, and education. Young people will be given the opportunity to participate in educational activities such as camps and workshops, designed to enhance their dialogue and critical thinking skills regarding past conflicts. Experts and representatives of civil society will be engaged in discussions, enabling broader involvement in fostering social and political change.
